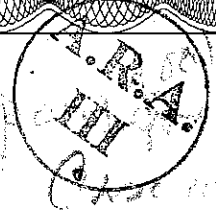

1. 2. In furtherance of the objects of the said Trust, the Trustees are desirous of establishing a School named as "Swarnim International School" and other Schools (hereinafter referred to as "the said School").
3. It was provided in the said Deed of Settlement that the Trust will be managed by a Board of Trustees consisting of not less than 3 trustees and not more than 7 trustees and the Board of Trustees shall have the power to increase number of trustees as and when required.
4. It was further provided in the said Deed of Settlement that any Trustee, including the Managing Trustee, may retire from the Trusteeship and that the Trustees shall have the power to appoint another Managing Trustee in place of first Managing Trustee to hold office for his/her lifetime.
5. The said (Smt.) Mita Kanoria, the Retiring Trustee No.1 herein, retired as Trustee of the said Trust on and with effect from 15<sup>th</sup> January 2016 and on and from the same day the Incoming Trustees were appointed as Trustees, with Swati Sarawagi appointed as the Managing Trustee.
6. Subsequently, the said (Smt.) Nita Dabriwal and (Smt.) Reeta Sarawgi, the Retiring Trustee Nos.2 and 3 respectively herein, also retired as Trustees of the said Trust on and with effect from 5<sup>th</sup> February 2016.

**I. NOW THIS DEED WITNESSTH as follows:**

- 1) It is recorded that the Retiring Trustees have retired as Trustees of the said Trust from the respective dates hereinbefore mentioned.
- 2) It is also recorded that the Incoming Trustees have been appointed as Trustees of the said Trust from their date of appointment as aforesaid and they shall have the same powers, authorities and discretions and shall in all respects act as if they had been originally nominated as Trustees under the said Deed of Settlement.
- 3) It is further recorded that the said Swati Sarawagi has been appointed as the Managing Trustee of the said Trust and she shall have the same powers, authorities and discretions and shall in all respects acts as such Managing Trustee as if she had been originally nominated as Managing Trustee under the said Deed of Settlement.

**II. NOW THIS DEED FURTHER WITNESSTH** That the said School will be under the control of the Managing Trustee and the Managing Trustee shall have the sole and exclusive right to take all decisions with regard to establishing, functioning running and operation of the said School, which includes amongst others the expansion thereof, closure of the same etc.

**III.** All other terms and conditions of the aforesaid Deed of Settlement shall continue to remain in full force and effect and shall apply mutatis mutandis.
